Welcome to your newsletter!

As we continue to live in unusual times, I hope that you and the children and young people that you care for are all keeping safe and well. I know that the rising number of positive covid cases in the Sandwell area continues to cause concern and is yet again having a negative effect on the education of children and young people. We can only hope that the vaccination rollout continues to provide protection and help us move back to some sort of normality on 19 July.

I hope that the information that we've include this month is helpful to you and I'll see you at the end of the newsletter.

Long Term Matching

We are so pleased to announce that the long-term matching panel for foster carers and the children in their forever family has begun! As you know, it is really important to children we care for to know that where they live and who they live with is secure, safe and long term.

In England long-term fostering has a formal status as a permanence option for looked after children. The child's local authority retains parental responsibility, but foster carers have greater authority to make decisions on behalf of the child and, if all parties are in agreement, meet less frequently with social workers. These changes were made in 2015 with the aim to provide better stability and a better sense of 'normal' family life for a looked after child.

Within long-term fostering, there is an expectation that the placement will continue throughout childhood until the young person leaves care and an aspiration that the relationships between the child and the foster family will endure into adulthood and indeed throughout life, on the basis of voluntary mutual attachments. This does not mean that the child will necessarily consider the fostering family as a "permanent" family to the exclusion of the birth family. One of the key advantages which long-term foster care can offer is respect for the continuing role of the birth family, and support for the child to maintain a relationship with their birth family unless this is considered detrimental to the child's interests.



In long-term placements, it is to be expected that the level of delegated authority – giving foster carers the authority to make decisions about a child – will be high, and this should be clearly established through the care planning process. In order to help ensure the success of long-term placements, it is important that long-term foster carers have access to relevant training as new issues arise. Foster carers may well need support to manage the changes in the child's needs which emerge over time, to manage changing relationships with the birth family, or to support the young person to prepare for independence, for example.

Long-term fostering placements may also require and benefit from a lower frequency of social work visits and formal review meetings (please speak to your social worker about this), although thorough support must be in place for the child and foster carer, and reviews must still take place by other means.

Is this something we should be working with you on? If so, please let your social worker know and we will consider booking you onto the panel.

Tots Talking Programme

Tots Talking is here in Sandwell and we want every parent/carer to have this wonderful, fun way of helping improve early language for our young children!

A second group of **amazing** foster carers who have just completed 8 weeks of Tots Talking, a programme developed by parents/carers to improve the language of 2 year olds and to get a head start at nursery and school.

It does this by encouraging parents/carers to use contingent language and behaviours to support children's language and communication skills.

These include turn taking, sharing the child's interests and adding onto children's comments. The programme includes research, video clips, spot the difference clips of contingent and non-contingent behaviours and language.

Every session is completed with a practical activity.

Tots Talking has been delivered through 8 online sessions that run once a week.

Each session lasts for 1 hour and 15 minutes. Tots Talking is a fantastic and fun programme!

The sessions are supported by the Tots Talking App which parents/carers use on their phone.

The App gives information to help parents/carers learn and encourage them to practice what they have learned with their child at home.

- The higher the response rate, the more the issues are understood in fostering and better influence improvement. For example The Fostering Network successfully campaigned for an extra £10m for Staying Put that has recently increased by £33m.
- The Care Review will be looking at the results to influence their work.
- Presenting findings to Ofsted inspectors to inform their inspections of fostering services.
- Inform campaigning work and organisational priorities to effectively support members.

Exclusive events to launch the results:

- These forums and events will give additional, anonymised and regional specific information from both surveys that can be used to improve your offer and services.
- Invites will only be sent to those who have provided their details through the survey.
- These events provide an opportunity to make individual, regional and national comparisons and looks at trends.
- The events will also provide networking and best practice sharing opportunities across the sector and will commence towards the end of the year.
